

# **USER MANUAL** Knotted Climbing Rope

**WARNING:** The disassembled product may contain small parts which pose a choking hazard to children under 3.

#### **IMPORTANT:**

The owner's manual contains safety, assembly, use and maintenance instructions. This product must be assembled by an adult who has read and understood these instructions. Keep the packaging away from children and dispose of all packaging before use.

For the installer and your children's safety, it is important to fully read and understand the instructions and safety hazards before commencing the assembly of the product.

## **ASSEMBLY INSTRUCTIONS**

Age Range: Above 36 months To be retained for future reference.

### () IMPORTANT:

- Before each use, please check product carefully for damage.
- Do not allow use of climbing rope until it has been installed properly by an adult, according to these instruction.
- By no means use the climbing rope as an infant seat.
- Only one child in the climbing rope at a time.
- Adult supervision required to make sure that children play safely.
- Make sure your child is dressed suitably to stop possible hazards happening while using the climbing rope. Your child should not wear loose clothing such as ponchos or scarves. Apparel should include well fitting shoes.
- Evaluate the following safety tips with your child before use:
  - Do not walk to close to, in front of, or behind the climbing rope while it is in use.
- Do not get out of the climbing rope while it is in motion.
- Do not push the climbing rope when it is not occupied.
- Do not twist or spin the climbing rope.
- Do not stand in the climbing rope.

#### 1. Location of apparatus

Minimal space in mm to respect between apparatus and structure of portico.

#### 2. Fixation of apparatus on the hook

The location of the hook carbine must be perpendicular in the axis of the beam of the portico, so that the balance of apparatus is correctly made.

The toy must be placed on a level surface at least 2 meter from any structure or obstruction such as a fence, garage, house, overhanging branches, laundry lines or electrical wires.

The toy shall not be installed over concrete, asphalt or any other hard surface.

#### 3. Control and Maintenance

Control regularly the state of the elements of suspension. Verify monthly the good tightening of all screws and nuts, and systems of fixation of apparatus, to prevent the falling risks replace all the damaged masks or missing nuts. Remove apparatus during the wintry period to avoid any premature degradation concerning the bad weather, from the slightest appearance of degradation of apparatus, and at least after 24 months of exposure outdoors, replace them by apparatus of the same conception. The change must be more frequent in zones with strong period of sunshine.
